Learning Matters Educational Group Loan Proposal for Thrive Point Academy of Nevada

<u>Purpose:</u> To provide a start-up funding for Thrive Point Academy of Nevada before the school receives State of Nevada Apportionment Funding.

Terms:

Loan Amount: Up to \$1,500,000

Loan Disbursement #1 Amount: \$700,000

*As of the drafting of this loan agreement, Learning Matters has incurred \$643,668.78 of start-up expenses for the development of Thrive Point Academy of Nevada. These expenses include principal salaries, facility rent, legal fees, marketing, and public relations expenses. The net proceeds of the loan funds will be reduced by the balance already encumbered by Learning Matters.

*As of 5-14-2024, Learning Matters has paid for \$643,668.78 of expenditures for the development of TPAN, which will be netted against the gross amount of the loan. An initial Loan Disbursement will be provided to TPAN in the amount of \$700,000 no later than 5 business days after approval from the TPAN Governing Board. The total amount outstanding after Disbursement #1 will be \$1,343,688.78.

A final calculation of expenses incurred by LMEG will be reconciled and provided to the TPAN Governing Board at the regularly scheduled board meeting on June 24th, 2024. Once the final calculation of incurred expenditures has been approved by the TPAN Governing Board, any remaining & necessary disbursement will be funded no later than 5 business days after approval from the TPAN Governing Board at the June 24th, 2024 board meeting. The combined total of Loan Disbursements and Start-Up Costs incurred by LMEG will not exceed the loan amount of \$1,500,000.

A full itemized list of these expenditures incurred by Learning Matters as of 5-14-2024 has been attached for reference.

Interest Rate: 3.00%

Loan Period: 36 Months beginning 1/1/2025 thru 12/1/2027.

<u>Proposal:</u> Learning Matters Educational Group (LMEG) acknowledges that Thrive Point Academy of Nevada (TPAN) needs start-up funding during Budget Year 0 and Year 1 before the school receives State of Nevada Apportionment Funding. Additionally, because TPAN is in its first year of operations, a significant amount of the school's revenue will be deferred until the end of the first fiscal year. Therefore, LMEG is proposing to fund the loan disbursements listed above in two installments – disbursement #1 of \$700,000 will be funded no later than 5

business days after the agreement is approved by the TPAN Governing Board at the regularly scheduled board meeting on May 20th, 2024. If necessary, Disbursement #2 will be funded no later than (5) business days after a final listed of incurred expenditures is presented and approved by the TPAN Governing Board at the June 24th, 2024 board meeting. The loan repayment schedule will not begin until January 1st, 2025. As presented in the Loan Amortization Schedule below, TPAN's first payment will not be due until 1/1/2025. During the period between LMEG funding the loan (May 2024) and TPAN making their first loan repayment (January 2025), there will be no compound interest charged - LMEG is simply deferring the loan repayment schedule until January 2025.
