TERMS AND CONDITIONS

- 1. Payment.** You agree to jointly and severally pay the amount(s) set forth above by the time period specified herein. At the time of acceptance, you may be required to pay a Deposit in an amount specified in the Order Confirmation. Except as set forth herein, all Deposits are non-refundable. After the payment of the Deposit amount, then the remaining balance owed under the Order Confirmation shall become due and owing immediately upon Budget Blind's installation of the products set forth therein. In the event Budget Blinds installs the products in separate parts, then you will be responsible to pay the remaining balance, less any Deposit paid, based upon the percentage of products that have been installed under the Order Confirmation with payment due immediately upon installation of each separate part. The percentage of completion shall be determined in Budget Blind's sole and absolute discretion at the time of each installation. If you refuse and/or fail to provide access to your property in order to allow for installation of the product(s) after request from Budget Blinds, then the entire remaining balance, less any Deposit(s), shall become due on the date in which Budget Blinds made its request for access. In the event you fail and/or refuse to make any payment when due, then you agree to pay interest on all amounts due and owing at a rate of 18% per annum until the entire amount, together with accrued interest and any recoverable costs and attorney's fees (outlined below) are paid in full. Finally, payment should be made to the order of Budget Blinds of Las Vegas, which you acknowledge Las Vegas BBlinds LLC as the Company. **Products.** You are solely responsible for the choices of all products selected, including but not limited to style, color, and controls. Budget Blinds bears no responsibility for any variations between such selections and your intended use or display of the products once installed.
- 2. Installations.** You agree to provide Budget Blinds with access to your home, property, or other location to permit the installation of products upon request of Budget Blinds. You agree to allow the free use of any services and utilities supplied to the property in order to allow for the carrying out the installation. The price specified herein covers the price of the products or merchandise and the installation of the same. In the event a condition arises that Budget Blinds was not aware of at the time it made its visual inspection of your Premises, Budget Blinds reserves the right to adjust its price in order to reasonably perform its work in accordance with the plans and specifications. Such adjustments shall be fully discussed with you and shall not include those conditions that should have been detected upon a reasonable visual inspection of your Premises. Such adjustment shall be billed on a time and material basis consistent with Budget Blind's practices and rates in effect at the time. Unless a different time is specified herein, the products will be installed and substantially completed within 90 days of your acceptance of this agreement, or payment of the Deposit amount, whichever is later. You understand this is only an estimated date and you will be contacted prior to this date to schedule the actual installation date.
- 3. Special Orders.** All product information must be accurate. Payments for special orders are non-refundable.
- 4. Warranty/Service Guarantee.** Budget Blinds makes no warranty, express or implied, regarding the products or the components and hereby disclaims all implied warranties of merchantability, implied fitness for particular purpose, or any other warranty which may be imposed under law or equity. The only warranty applicable to the products shall be those provided by the manufacturer. That said, Budget Blinds does provide a service guarantee. The service guarantee period shall begin on the date of installation and run for a period of 90 days (the "Guarantee Period"). During the Guarantee Period, there shall be no labor charges incurred by the customer for service/repairs, regardless of reason or fault. If service is required during the Guarantee Period for repairs not covered by the original manufacturer's warranty, you will be responsible for the cost of replacement parts and/or shipping charges. After the Guarantee Period expires, there will be a minimum of \$75 trip charge per visit, regardless of reason, for any services provided to you, plus a standard hourly service rate is \$75. 
