# SPCSA's Proposed Motion 2023

**Proposed motion:** Approve the Thrive Point Academy of Nevada resubmitted application as submitted during the 2023 Application Cycle, with the conditions as permitted by NAC 388A.410 and as outlined below, based on a finding that the applicant has met the requirements contained in NRS 388A.249(3) in that the applicant has demonstrated competence in accordance with the criteria for approval prescribed by the SPCSA that will likely result in a successful opening and operation of the charter school.

1. Enrollment will be capped at 450 students in year two and each remaining year of the charter contract. Once the school is officially approved for the Alternative Performance Framework by the Nevada State Board of Education, the board may apply for an amendment to increase enrollment. If approved, the Thrive Point of Nevada enrollment cap will be:

# TPAN's Alternative Performance Framework (APF) Status

---

TPAN has exceeded the requirement of 75% of students meeting the criteria for alternative school status. TPAN's APF application was submitted by the Nevada Charter Authority staff and is on the consent agenda to be approved at the May 14 Nevada State Board of Education Board Meeting. This alternative school application was a major accomplishment and a team effort by the staff of TPAN along with members of the LMEG team and the TPAN school board. Congratulations to Vince Medina and his team for their diligent work.



# TPAN's Alternative Performance Framework (APF) Status

---

Since the Alternative Performance Framework (APF) will be approved by the Nevada State Board of Education (NSBE) TPAN may apply for an amendment to increase enrollment. TPAN could request the enrollment growth plan that was already agreed upon by the SPCSA.

However, TPAN has proven that there is demand for our unique program and model. TPAN has met and exceeded our enrollment target when other schools have not. We believe TPAN should ask for an accelerated enrollment plan including a higher enrollment cap for each year and adding additional sites each year as well.

In light of the enrollment growth trends that we have noticed in Nevada as well as other states where LMEG schools operate, We would like to propose a new growth plan.

# TPAN Growth Plan

---

TPAN needs to grow both with:

1. adding resource centers, and
2. growing the online student population.

Moving to Reno allows TPAN to:

1. add an additional campus outside of Clark County. Additionally,
2. TPAN is clearly recognized as a statewide virtual school with the capacity to enroll students throughout the state.

TPAN also plans to add additional resource centers in the four largest cities of Clark County:

1. Las Vegas,
2. Henderson,
3. North Las Vegas,
4. Enterprise.



# Is there a need for more alternative education programs for high school students in Reno, Nevada

---

Yes, there is a clear and ongoing need for more alternative education programs for high school students in Reno, Nevada. While existing programs provide valuable support, current offerings may not fully address the diverse and growing needs of at-risk youth in the region.



# Existing Alternative Education Options in Reno

---

Reno currently offers several alternative education programs aimed at supporting students who face challenges in traditional school settings:

- **ThrivePoint Nevada:** A tuition-free alternative high school serving students who are behind on credits, have been held back multiple times, receive special education services, are suspended or expelled, or are under court supervision. [thrivepointnevada.com](http://thrivepointnevada.com)
- **Turning Point:** A self-contained program within the Washoe County School District (WCSD) designed for students requiring a more structured educational environment. [washoeschools.net](http://washoeschools.net)
- **Redfield Academy:** Operated by The Children's Cabinet, this program assists students at risk of dropping out by offering credit recovery and the opportunity to earn a traditional diploma or High School Equivalency (HSE). [Children's Cabinet](http://Children's Cabinet)
- **Washoe Inspire Academy:** Focuses on creating a safe, caring, and academically rigorous environment for students needing alternative educational pathways. [washoeschools.net](http://washoeschools.net)
- **North Star Online School:** Provides a full-time, virtual public school option for students in grades K-12, offering flexibility for those who may not thrive in traditional settings. [washoeschools.net](http://washoeschools.net)

# Indicators of Unmet Needs

---

Despite these programs, several indicators suggest that the current alternative education landscape may not sufficiently meet the needs of all at-risk students:

- Chronic Absenteeism:** WCSD has reported chronic absenteeism rates exceeding 24%, highlighting a significant portion of students disengaged from traditional schooling.
- Graduation Rates:** Statewide data indicates that nearly one in five Nevada students does not graduate within four years, with higher dropout rates among English Language Learners, students with disabilities, those experiencing homelessness or in foster care, and students identifying as American Indian/Alaskan Native, Black/African American, or Hispanic/Latino.
- Limited Program Capacity:** With only four alternative schools listed in Washoe County, the capacity to serve all students in need may be insufficient.



# Opportunities for Expansion

---

The Nevada Department of Education emphasizes the importance of alternative education programs and encourages districts to assess and address local needs. Additionally, Governor Joe Lombardo's recent initiatives include the creation of an Office of School Choice and increased funding for educational programs, potentially providing resources for the development of new alternative education options. # Reno's Population Growth Trends

---

**City of Reno:** As of July 1, 2023, the estimated population was 274,915, marking a 4.1% increase since April 2020. [Census.gov+1Reno Gazette Journal+1](#)

**Reno-Sparks Metropolitan Area:** Between July 1, 2023, and July 1, 2024, the metro area grew by 8,124 residents, reaching a total population of 575,100. This represents a 1.43% annual growth rate. [Reno Gazette Journal](#)

**Long-Term Projections:** Forecasts suggest that the Reno metro area will continue to grow, with a projected population of 841,398 by July 2029, reflecting a 4% increase over five years. [Synergos Technologies, Inc.](#)



# ThrivePoint Arizona Enrollment Trends

---

ThrivePoint Arizona has experienced rapid growth over the last three years. While ThrivePoint's resource centers are growing, recently the growth rate of ThrivePoint's 100% online program has grown at a more rapidly than has the enrollment at resource centers.

This trend is occurring for a variety of reasons. TPAN should be reviewing this data as well to prepare to take advantage of current and future trends. Currently TPAN has an enrollment cap, but once this cap is increased, online enrollments can grow within Nevada as TPAN waits for approval for additional resource centers.

It is in the best interest of TPAN to grow in both online enrollment and in resource center enrollment. This methodology will allow more students to be served and will allow TPAN to grow and become sustainable both academically and financially.



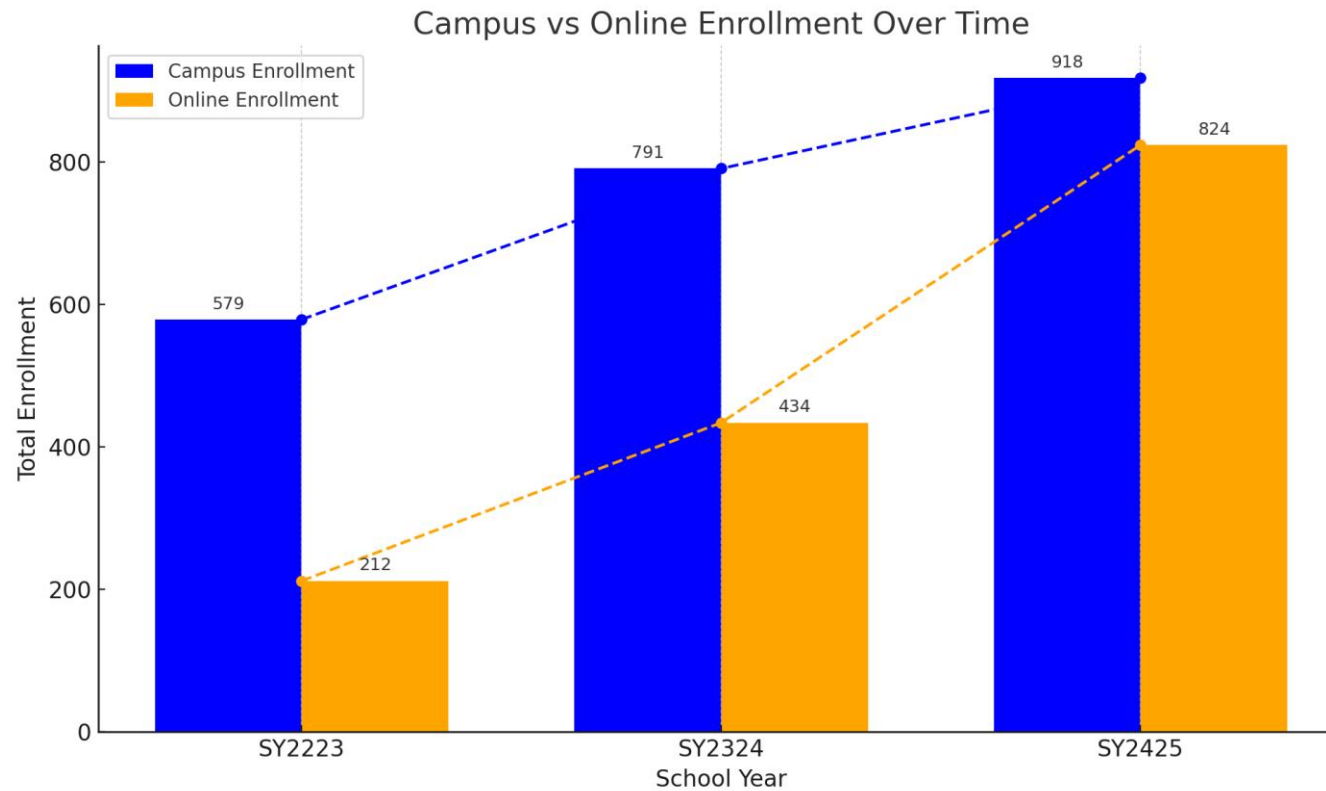

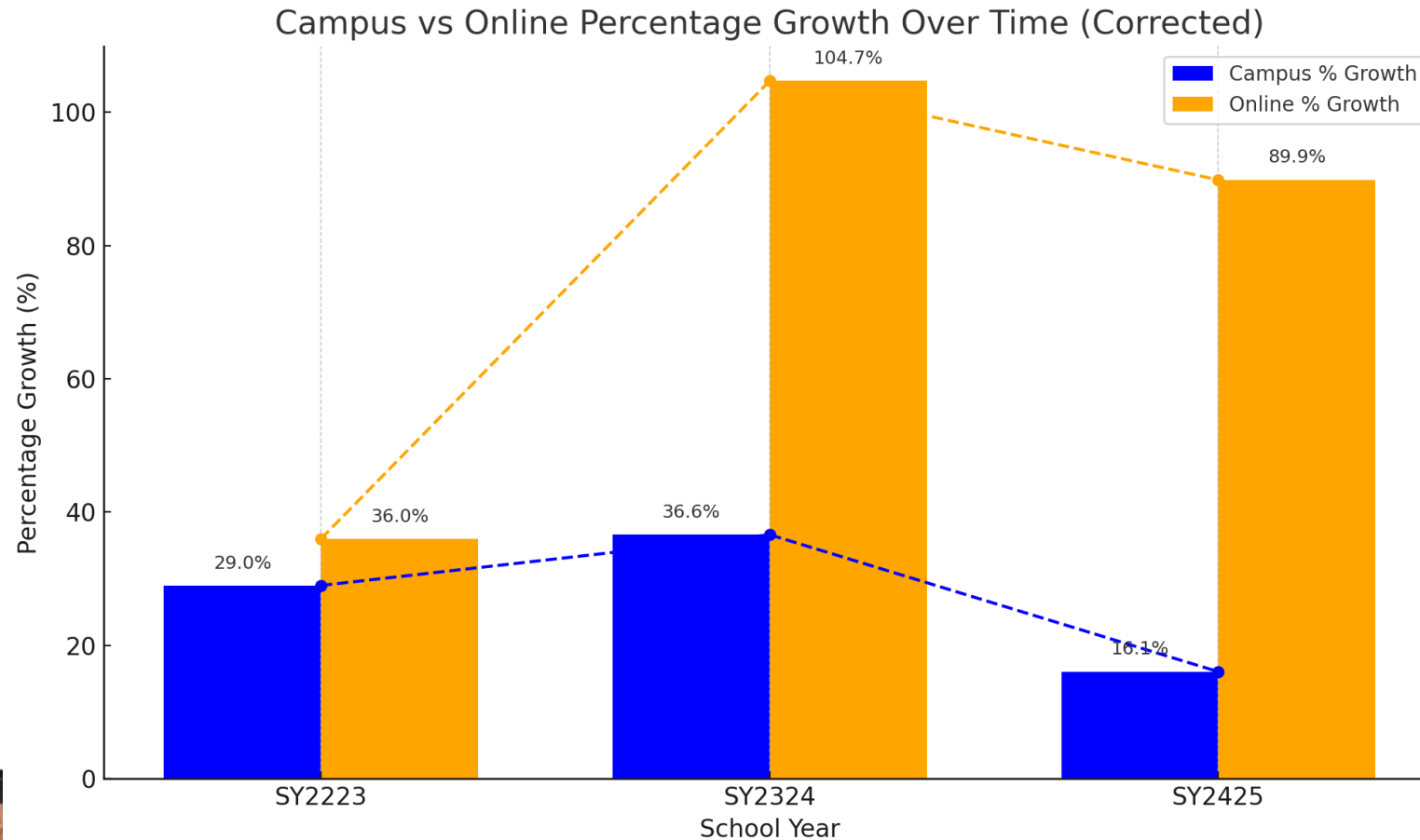

# Key Takeaways from ThrivePoint Arizona Data

---

1. **Online enrollment grew explosively** (105% in SY2324, ~90% in SY2425).
2. **Campus growth slowed** (36.6% → 16.1%), while online growth remained high.
3. By SY2425, online enrollment is **nearly matching campuses** (824 vs. 918).



# Conclusion

---

TPAN is aware that there is a step-by-step process for both enrollment caps to be increased and for site expansion approvals.

It is our goal to potentially submit a notice of intent by September 1 of the fall cycle to inform the SPCSA of our intent to submit a request for amendment (RFA) by October 1-15. This possible RFA could include asking for:

1. an increase in TPAN's enrollment growth and
2. possibly begin working to add an additional resource center in North Las Vegas and
3. to possibly add an online student enrollment office in Reno.

At this point we are just surveying the areas of Reno and North Las Vegas to find out more about the need for additional campuses and to do our due diligence before submitting a formal RFA.
